\*\*\*\*\* For the purposes of a student loan, an unprovided-for child is a student up to the age of 26 years. Any student who has already graduated from a university (finished masters studies - degree II.) and has been awarded an academic title is not an unprovided-for child. Any student receiving a disability pension due to a decrease in their ability to perform gainful employment by more than 70% is not an unprovided-for child.
